Attention Exhibitors

SHOW SITE WILL BE AVAILABLE FOR SET UP FROM 5:00 TO 7:00 PM FRIDAY. Saturday & Sunday the show site will be available to exhibitors at 7:00 AM. **C MATCH will begin Friday at 5pm.**

Telephone, email, and unsigned entries cannot be accepted. Entries not on an Official AKC Entry Form and photocopies of entry forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

Make all checks and money orders payable to Coulee Kennel Club. Payment must accompany entries. **Mail all entries to Abby Flak, 3706 Co Rd W40, Decorah, IA 52101.** Entries received without fees will not be accepted. Acknowledgment of entries will be made as soon as practical. Unless an exhibitor specifically requests postal communication, submission of an email address on the entry form will serve as authorization to send communication, including entry confirmation via email. It is the exhibitor's responsibility to ensure that their email software will accept messages from abbyflak@gmail.com

Entry fees shall not be refunded if a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of Show Committee or AKC. The well-being of dogs, exhibitors and spectators is of paramount importance, and in the event, it is necessary to cancel or stop the show before completion, no refund of the entry fee will be made.

Coulee Kennel Club does not agree to arbitrate claims as set forth on the Official AKC Entry Form for the events.

Owners are responsible for errors on completed entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. Changes, additions, or corrections to entry forms must be received prior to the closing of entries.

Post-dated and returned checks do not constitute a valid entry. A collection fee will be added to the amount of each returned check.

No refund for duplicate entries. Care will be taken to find duplicates, however, if an entry has been processed, no refund will be made. No entry shall be made, and no entry shall be accepted which specifies any conditions as to its acceptance.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. There will be no refunds of entry fees if a person is asked to leave the trial site.

Dogs may arrive any time prior to their scheduled judging. Dogs not required for further judging may be excused. Owners or agents are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

CKC, the show secretary, members of the show committee, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by spectators, exhibitors, handlers, their employees, or children, etc. or to any of their dogs or property. Entrants and spectators at this show do so entirely at their own risk. This show is governed by The American Kennel Club. Exhibitors should read the AKC agreement on the entry blank in the premium list.

Rally classes utilizing jumps will be run in the following order

Saturday: Ascending jump height

Sunday: Descending jump height

Obedience Regulations: ALL DOGS MUST be on a leash or kenneled unless showing in the ring.

Coulee Kennel Club (CKC) may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness, or other cause, and no one shall have any claim or recourse against CKC or any official thereof. No entry fees will be refunded if the trials cannot open or be completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee. CKC reserves the right to cancel these trials in the event of extreme weather conditions and no entry fee refunds will be made in such case. Bitches in season are not permitted in the Trial. Exhibitors may request a refund of entries, minus a \$10 per entry processing fee, for bitches that come into season after the closing date, as long as the trial secretary is provided documentation from a veterinarian at least 30 minutes prior to the beginning of the day's judging. Coulee Kennel Club policy allows the Obedience/Rally trial secretary to enter these events. Refunds will not be given for over payments of \$10 or less.

Non-Titling Classes Offered

Rally Pairs

One Handler, Two Dogs! Working together through a rally course at the level selected and offered. This is like 'Brace' in obedience, with the option of the dogs being connected to each other. Scores will be based on a possible 200 points with ties being broken by time. No Jumps! For Excellent Level.

Team Rally

Four Handlers, Four Dogs! A fifth dog may be entered as an alternate at no additional fee. However, only four dogs may compete on the team.

No dog may be entered on more than one team for that level.

Dogs can compete at any level despite their title.

Each dog and handler team will run the course individually and be scored individually... however the team time starts when the judge says 'Forward' with the first team member and ends when the fourth team member crosses the FINISH sign. The time runs continuously, similar to a relay race!

Jump heights will be set for the height of the smallest dog on the team.

Team scoring is based on 400 points, or 100 points per team member.

Ribbon and Rosette Prizes

First Place: Blue Ribbon

Second Place: Red Ribbon

Third Place: Yellow Ribbon

Fourth Place: White Ribbon

Qualifying Scores: Green Ribbon

Highest Combined Rally Score: Rosette and \$25 cash

Highest Combined Triple Score: Rosette and \$50 cash

Highest Scoring Dogs in Rally Pairs: Rosette and \$50 cash

Highest Scoring Dogs in Team Rally: Rosette and \$100 cash

Special title ribbons will be given to dogs that complete Rally Championship at this trial.

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person.
